1. Parties

This License Agreement (“Agreement”) is made between:

2. Grant of Rights

Upon purchase, the Licensor grants the Licensee a non-exclusive, perpetual, worldwide, non-transferable license to use the Fauna Pro font software (“Font Software”) under the following terms:

2.1 Desktop License — Unlimited

- Licensee and all employees/contractors working for Mundbora Inc. may:
- Install the Font Software on unlimited workstations.
 - Use it to create static graphics, logos, print media, packaging, presentations, video frames, and all other 2D/3D rendered output.

2.2 Webfont License — Unlimited

- Licensee may embed The font as a webfont on unlimited domains owned or operated by Licensee.
- Unlimited monthly pageviews allowed.
- Webfont files may be self-hosted.



2.3 Digital Advertising & Email License — Unlimited

The Font Software may be used in unlimited email campaigns, digital ads, social media assets, banners, and digital marketing materials.

2.4 Electronic Document License — Unlimited

Font may be embedded in unlimited electronic documents, including PDFs, e-books, presentations, apps, and internal documentation, provided the fonts are:

- embedded in a non-extractable format, and
- not distributed as editable font files.

2.5 Unlimited Users (within Licensee)

All employees, contractors, or collaborators producing work for Mundbora Inc. may use the Font Software without quantity limits.

3. Usage Restrictions

The Licensee agrees to the following:

3.1 Brand Restriction

All permitted usage must belong to or be directly associated with Mundbora Inc. Use by or on behalf of other brands, clients, subsidiaries, or external entities is not allowed unless a separate license is purchased.

3.2 No Redistribution

Licensee may not:

- resell, share, lend, distribute, or make the Font Software available to any third party;
- provide the Font Software as part of a template, product, or service where the font files themselves could be downloaded or extracted.

3.3 No Modification or Derivative Fonts

Licensee may not modify, convert, rename, or create derivative versions of the Font Software, except for internal technical formats (e.g., WOFF/WOFF2) explicitly required for web embedding.

3.4 No Use in AI Training

The Font Software may not be used to train, fine-tune, or evaluate machine learning, OCR, or generative AI systems.

4. Ownership

- The Font Software is the intellectual property of Taras Pasternak.
- This Agreement grants usage rights only; it does not transfer ownership of the font designs or software.
- All rights not expressly granted here remain with the Licensor.



5. Warranty & Liability

The Font Software is provided “as is.”
The Licensor is not liable for direct or indirect damages, business loss, or claims arising from the use of the Font Software.
Licensor will make reasonable efforts to correct file defects if notified.

6. Term & Termination

- This license is granted for unlimited time (perpetual), unless terminated.
